Draft 2022 Budget Presentation

Sharon Corbett presented the overall budget presentation:

- Includes direct and indirect cost of running the SDV WG
- SDV WG budget rolls into overall Eclipse Foundation budget
- SDV WG has significant amount of budget this year, compared to average
- Eclipse Foundation fiscal year == Calendar year

Dennis Leung presented the 2022 budget breakdown

- Marketing Manager has been hired, will start end of June
- Community/Program Mgr: interviews in progress
- Details on General Mgr to follow soon
- Marketing Events:
- Currently ~4 events planned: 2 contribution days, 2 hackathons (EclipseCon and BCW)
- Discussion about cost/value proposition of BCW offering is ongoing

Dennis Leung presented the 2023 budget plan

- Surplus from 2022: acceptance required by EF executive director, process in progress and expected to go through

Q: are the ppl/roles expected to be SDV full-time?

A: not necessarily - some roles will share with other scopes, but the three managers (program/marketing/general) are dedicated for SDV WG

- 2023 will only be finalized towards Q4 this year - refined and updated until then

Q: Budget adjustments possible after plan approval?

A: Yes, this is done somewhat routinely; exceptions are for fixed-allocated money like for salaries, but otherwise adjustments are not a problem. The Steering Committee can discuss and put forward such changes to the Eclipse Foundation.
